# **Our Services**

#### **Therapeutic Residential Care**

Residing Hope served more than 1,300 children last year through our various programs across the state. Our programs care for at-risk children through 17 years of age on our main campus in Enterprise as well as our Madison Youth Ranch. Unique care plans are created to meet each child's individual needs, including specialized therapeutic care and a specific program for those traumatized by sexual abuse. Our Enterprise campus includes our Legacy Scholars Academy, a partnership with Volusia County Schools that includes a Social-Emotional Learning (SEL) component as

well as specialized educational programming to further help our children succeed. A child's residential length of stay varies depending on his or her needs, but no matter how long a child is in our care, we give them hope, love, and a safe place to call home.

#### **Outpatient Counseling**

Circle of Friends Services was originally founded in 2009 and became a division of the Florida United Methodist Children's Home in 2019. Now known as Residing Hope Outpatient Counseling, we provide trauma-informed services to children and families in homes, at school, or

an office location, as well as virtually across the state. Our therapists are specially trained to help families return to normalcy after suffering the traumas of addiction, abuse, neglect, and separation.

#### **Foster Care**

Our Foster Care program recruits and trains foster parents, and licenses foster homes in Volusia, Flagler, Broward, and Palm Beach Counties. Foster Family Cottages are also located on our Enterprise campus, allowing those families to benefit from services there including our on-campus school, our Spiritual Life program, and other residential services.

#### **Childhood Education**

Residing Hope Montessori, our licensed childhood education program, is located on our Enterprise campus and serves the surrounding community. It serves children from birth through middle school, as well as after school and summer programs.

# Bri's Story

Bri came to Residing Hope after being removed from her biological home. Her mother was an alcoholic, and unable to provide for Bri. When she first arrived at our Enterprise campus, Bri was nervous because she didn't know what to expect. Having been subjected to neglect, she found it difficult to trust adults. The staff, especially the Teaching Parents in her cottage, soon helped her to feel safe. Bri is now doing well in school. In addition, she is very active in our Spiritual Life and Recreation programs.




